## REAO Endorses Tom Beckett – We Need Your Vote!

**Background** On July 30, 2013 the Orange County Retirement System (OCERS) mailed notices to all retirees to inform us of the upcoming election to fill the position of the Retired Member on the OCERS' Board of Retirement. This election will select a retiree who will fill a three year term which will begin on January 1, 2014. Ballots will be mailed to all retired members on September 13, 2013. Ballots must be returned to the Registrar of Voters no later than October 24, 2013.

**Recommendation** Your REAO Board of Directors has conducted interviews of several retired candidates seeking our endorsement. After careful and thorough consideration, we have endorsed Tom Beckett as the best suited and most qualified retiree to fill this position.

Tom retired from the County after 32 years of service, most of which were spent working with OCERS. Tom has had a distinguished financial career and at the time of his retirement he was the County's Public Finance Manager, responsible for overseeing several billion dollars in funds. Tom's educational background includes a Bachelor's degree in Economics and a Master's degree in Business Administration (finance

emphasis) from UCLA.

While at the County, Tom worked in the Auditor Controllers Office, at John Wayne Airport and in the County Executive Office. Tom played a leading role in the recovery team to lead the County out of bankruptcy in 1996. He was the Finance Officer at John Wayne airport during the airport's major reconstruction project.

Tom has worked with OCERS for nearly two decades. As the Public Finance and Risk Manager for the County of Orange, he worked closely with OCERS on pension obligation bonds, retirement rates, actuarial reports and assumptions as well as amortization periods and assumptions. Tom was the County's face on Wall Street regarding pension liability issues. His understanding of how the county and the retirement system work together is second to none. He is no stranger to fiduciary responsibility, monies held in trust and investment opportunity.

Tom has been a member of REAO for a number of years and has participated in our activities including luncheons and Board meetings. It is for these and many other reasons we have endorsed Tom Beckett as the Retiree Representative

# Presidents' Message

## From the Desks of Linda Robinson and Doug Storm

Welcome back from summer break, retirees! We hope your summer activities were enjoyable and you were able to experience an abundance of relaxation time. Labor Day celebrations traditionally signal the end of summer and tell us a change of season is just around the corner. May everyone welcome the autumn of 2013 and thoroughly enjoy the changing scenery, times and mellow richness of the new season.

Your REAOC and AREOC Board of Directors has worked diligently throughout the summer months on behalf of our membership by monitoring legislation and Board of Supervisor meetings, assisting REAOC attorneys in litigation efforts, initiating planning efforts to host a 2014 CRCEA Spring Conference here in Orange County next April, attending OCERS Board and financial meetings, reviewing current events related to emerging retiree issues and working with County Human Resource staff to ensure a one-time source of revenue be used to reduce what are significant 2014 health premium costs for many retirees. Additionally, your Board members interviewed several candidates seeking REAOC endorsement in the upcoming October election for the retiree member to replace Bob Griffith on the OCERS Board. Needless to say, it's been an active, challenging summer.

### 2014 Health Insurance Rates

In July the Board of Supervisors adopted 2014 retiree medical insurance premium rates. REAOC was not included in the rate setting process.

Rates vary by plan—some with considerable increases—others with minimal change. Rates are posted on the REAOC website at [www.reaoc.org](http://www.reaoc.org). It will be very important for retirees to thoroughly review all health plan options when selecting a plan which takes into account medical service needs and financial considerations. We highly recommend attending one of the county-sponsored seminars this fall to understand options and to ask questions.

**Litigation Update** As previously reported all briefs in the REAOC vs. County of Orange lawsuit have been submitted to the Ninth Circuit Court of Appeals. In July, however, the county filed several procedural motions in the Ninth Circuit in an attempt to prevent REAOC from making certain arguments and presenting certain evidence to the appellate court. REAOC was required to prepare briefs responding to each of the motions. The court has ruled in REAOC's favor on the most important of those motions. That ruling cleared the way for the court to schedule the hearing, which it said would be "at the earliest available date." The remaining motions will be decided closer to the hearing date, and we expect to learn very shortly when that hearing will be. It's difficult to predict but our best estimate is that we will have a hearing sometime this fall at the Ninth Circuit courthouse in Pasadena. Once scheduled, notification of the date will be made via the REAOC website, email distribution list and *The Informer*. When

# In the News

**N**ationally: Americans ages 75 and older lost 1/3 of their household financial assets and 1/6 of their net worth from 2007 to 2010, reflecting the devastation of the 2008 crash, according to studies presented in July at a Financial Security Summit organized by the Aspen Institute, reported Michael Hiltzik in his July 17 *Los Angeles Times* column. "Their balance sheets may have improved since then, but obviously they have less time than other age groups to make up the losses," Hiltzik said.

A study found that most age groups have sharply paid down their credit card debt since 2007; however, credit card debt among the oldest retirees has risen. From 2007 to 2010, AARP found, the percentage of families 75 and older with credit card balances rose from 18.8% to 21.7%. The rate fell in every other age group.

The rule of thumb (developed back in 1993)—that retirement assets can be made to last 30 years if one withdraws 4% of their original value every year—may not work when inflation-adjusted interest rates remain close to zero, as they are today, over long periods, or where the nest egg has been slashed by a third.

Retirees causing a brain drain? Some 30% of the federal workforce will be eligible to retire in the next three years, according to a Government Accountability Office report, *CNN Money* said. That means the U.S. government could be hit by a wave of retirements at a time when it is already dealing with inadequate staffing because large numbers of employees are on furlough and hiring

freezes are in place to save money and dramatically shrink the federal budget deficit.

"We're seeing this massive brain drain as thousands of workers leave...and it's leading to a huge loss of knowledge and expertise," said William Dougan, president of the National Federation of Federal Employees. "A lot of these jobs are not being filled once they're vacated." It's already leading to questionable outcomes. In the past two years, the IRS has lost 10,000 employees to retirement and attrition and more than a third of IRS employees will soon be eligible to retire, which could lead to longer waits for taxpayers refunds and audits. Further, some 46% of air traffic controllers can retire in the next three years, creating a challenge to replace them with similarly experienced workers.

Analysts warn of a dangerous downward cycle. Perceptions of government as dysfunctional and politics as corrupt keep getting worse. That convinces some of the nation's ablest people, especially those just starting out, that they don't want to run for office or work for the government at any level. A new *USA Today / Bipartisan Policy Center* poll finds that Americans by more than 2 to 1 say the best way to make positive changes in society is through volunteer organizations and charities, not by being active in government. "These two worlds of civic life and of public life used to be almost the same world, but these worlds have clearly separated," says Paul Light, a professor of public service at New York University. Among the students

he teaches, he sees "a general sense that politics is for losers, for ne'er-do-wells, for the corrupt and for the under-motivated and greedy." Others involved say encouraging public service is likely to depend less on mandates and more on demonstrating that government can address the nation's big problems—especially for younger Americans who have grown up watching a system that often seems paralyzed.

**Detroit bankruptcy and public pensions:** The city's historic bankruptcy has ignited a largely uncharted legal front in the closely watched battle between public employee unions and governments across the country struggling to meet costly pension obligations, reported the *LA Times*, July 20. In Sacramento, Amy Norris, a spokeswoman for CalPERS, said: "We will be watching what happens in Detroit." So are the cities of Stockton and San Bernardino, which have also filed for bankruptcy protection. The Detroit unions said the city had failed to negotiate in good faith. And while pension fund officials contend that the state constitution protects pensions, others argue that federal bankruptcy law trumps state law. Furthermore, current and retired public employees could find themselves competing with municipal bondholders for payment. "Truth be told, we know nothing," said Karol Denniston, a San Francisco-based attorney who specializes in municipal bankruptcy. "We know that under bankruptcy code there's an ability to impair creditors, but whether that extends to pension obligations—there is no answer."

# CRCEA Continues to Move Forward with the Protection Theme

The Retired Employees of Los Angeles County hosted the CRCEA Annual Spring Conference at the Hotel Maya in Long Beach April 15 to 17. Due to the close proximity, it was attended by a larger than normal REAOC and AREOC contingent of both board members and members at large.

Board attendees were REAOC Co-Presidents Doug Storm and Linda Robinson, AREOC President Sara Harms, Directors Faye Watanabe, Gaylan Harris and Lou Scarpino and Office Manager Ilene Barcenas. Program offerings spanned both retiree and retirement system issues and were notable for the retiree protection orientation that is increasingly becoming the direction in which CRCEA is moving.

This retiree protection theme was carried through to the ending conference Executive Committee session wherein the Ad Hoc Retirement Security Committee (RSC) was unanimously approved to continue its work. Regular readers of *The Informer* will recall that the RSC is the CRCEA statewide committee that produced the "401k-Train Wreck in the Making" white paper series.

Discussion of threats resonated with delegates and executive committee board members alike. They include the continued unfunded liability problem—not fully resolved by pension reform legislation in California, accounting changes that will exacerbate the public relations aspect associated with defined benefit systems, legal challenges to treat

pensions on an equal footing as any other debt in bankruptcy proceedings, and the massive incentive to 401k product conveyors that \$3.2 trillion of state and local government defined benefit pension funds like ours represent.

While the protection theme underlies much of CRCEA's activities these days, Conference programs are also structured to provide education to our Association Directors to help maintain the health of our retirement systems. Toward this end, the usual Legislative Report update from our lobbyist Amy Brown and California Assembly and Senate pension committee chief consultants included detail on the current focus to develop clean-up and conforming legislation to pension reform provisions signed by the Governor last year.

In addition, Gregg Rademacher, CEO of LA's retirement system LAC-ERA, presented on the opportunities retirement systems have to collaborate with stakeholders. He demonstrated that there is ample room to find common ground for solutions through simply improved communication—agenda driven press notwithstanding. His work in this area is a welcome change from the now all too familiar and dominant antagonism in the pension arena.

Turning now to speakers who presented on issues of particular import to our association members, the following highlights are offered.

"Protecting the Elderly Against Scams" was the subject of Daniel J. Kinney's presentation who serves as

a Deputy District Attorney in the LA County Elder Abuse Unit. He provided valuable insights into some of the many scams perpetrated against our nations seniors who are targeted because they have money and other resources and are more easily victimized when alone, isolated and outside dependent protection.

"Secrets to a Happy and Healthy Retirement" was the topic presented by Assistant Professor Tara L. Gruenewald, Ph.D., MPH who teaches at USC's Leonard Davis School of Gerontology. Professor Gruenewald began by noting that we now live in what is becoming known as the "Third Age," defined by a generation now nearing 20 years of life after age 65. Therefore we now must find a way to Age Successfully and Well.

"Financial Management After Retirement," the subject of LA Treasurer/Tax Collector Mark Saladino's presentation centered on homes—most retirees' largest investment. He pointed out that your home can help meet retirement goals including Property Tax Transfers and Reverse Mortgages.

The Retired Employees of Fresno County, REFCO, will host the CRCEA 2013 Fall Conference on Monday, October 21, 2013 through Wednesday, October 23, 2013 at the Radisson Hotel & Conference Center in Fresno.

REAOC will be hosting the CRCEA Spring 2014 Conference and planning is already underway. If you would like to volunteer to assist with con-
