IV. IRS Changes Impacting 501C4 Organization

Sara Ruckle Harms discussed the changes in regulations for 501(c)(4) and the complications that can ensue. She also recommended that we hire a professional Accountant/Treasurer. That person would manage all the monies and he/she would keep the accounting of the funds. He/she would manage the bank account but our in-house treasurer would also be on the account. There would not be a requirement for two signatures on the checks and only the professional would write the checks. Professionals are familiar with all the State forms that need to be filed. We would still have an in-house treasurer who would report out the activity of the professional

treasurer. The cost of this would be approximately \$1,500 - \$2,000 per year. Several of the Act 37 counties are also 501(c)(4) organizations. She would suggest that we could utilize Gary Crommet who helped us during the Correa campaign.

Action Items: Lou Scarpino will contact other CRCEA counties to determine if they do their own accounting/reports or if they use professionals.

Sara Ruckle Harms will reach out to Gary Crommet regarding this opportunity.
