Presidents' Message

From the Desks of Linda Robinson and Doug Storm

On behalf of the entire REAO and AREOC Board of Directors—Happy Springtime, Retirees. What a grand time of year. We welcome the arrival of nature's annual, transformative process and on March 12th we can enjoy the arrival of daylight savings time. This is a time of change and activity on many fronts. Challenges may confront each and every one of us on this adventurous journey we call life, but we will meet those challenges because we are a hearty bunch with incredible experience, determination and unity.

CURRENT ACTIVITY Following the January issuance of retiree pension checks a number of REAO members immediately noticed discrepancies in deductions. The majority of disparities were related to insurance coverage and grant offsets. Some retirees were told their coverage had been dropped after

contacting Secova, the new Benefits Center Administrator, while other retirees were informed of this contention directly from their service providers. REAO Board members straightaway met with County and OCERS staff to determine the extent of the problem and to seek resolution. We learned the irregularities were the result of a complex transition of contracted administrative data services from one Benefits Center vendor to another. Adding to the dilemma was Open Enrollment changes and additions. Board members have met a number of times with OCERS and County staff to discuss and resolve these important issues. Significant corrective action has been taken by the County; however, the best laid plans could still result in some recurring, unresolved individual issues. If that should occur, please contact Secova—the new administrator. The number to call is 1-800-858-7266. By now, you should have received a letter from the County explaining details of the issues raised and subsequently addressed during the contract transition.

Be assured, retiree medical continues to be a primary focus for your Board of Directors. In February, members of your Board met with

The mission of REAOC is to promote and maintain fellowship and camaraderie of OCERS retirees and their spouses by sponsoring social and recreational activities and by maintaining contacts via the newsletter, the REAOC website, e-mail, or other means of communication. A secondary purpose is tracking and dissemination of information relating to pension and legislative actions, financial matters, physical and mental health care, volunteer and employment opportunities and other concerns that may be of interest to our members.

OCERS retirees and their spouses are eligible for regular association membership. Dues are \$3.00 per month, payable through payroll deduction. Luncheons are held at Mile Square Golf Course in Fountain Valley on the fourth Wednesday of January, March, May and September, and on the first Wednesday of December. A local chapter of REAOC is active in Hemet.

2017 Keith L. Concannon Scholarship Program Reminder

Scholarship applications are due by April 1, 2017 and must be submitted and received electronically. Applications may be requested by telephone at the REAOC office or by email at reaoc@reaoc.org.

Remember, applicants must be related to a REAOC member, although Orange County residency is not required. Students who are related to a member of the REAOC Board of Directors or the Scholarship Committee are not eligible to apply. Also ineligible are students who have

already received a REAOC scholarship grant.

Qualifications: Applicants must be full-time students having at least a 3.0 grade point average on a 4.0 scale. Students must be either high school seniors who have been accepted as full-time candidates for a college degree program in the Fall, 2017, or students already pursuing a degree at an accredited educational institution. These include colleges and universities, institutions authorized to provide full credit toward a

bachelor's or higher degree, and accredited institutions, authorized to train students for gainful employment in a recognized occupation.

NOTE: The official high school or college transcript and reference letter must be mailed separately with a postmark no later than April 1, 2017. The application instructions should be thoroughly reviewed for requirements.

Snakes, Water and Yachts

The record-setting storms that swept California in January reminded me of another time when major rain hit Southern California.

It was early in 1969 when runoff from Saddleback Mountain and the surrounding Santa Ana Mountains caused Santiago Creek to roar to life with raging water. Irvine Lake filled and ran over the spillway, with the resultant torrent rushing through Irvine Park, causing significant loss of land and vegetation. Next on the creek was the relatively new Villa Park Dam built and operated by the Orange County Flood Control District. It filled up and the spillway became a torrent. Downstream in east Orange a large gravel pit (today Katella Avenue crosses the upper end of that pit) filled up and brought the creek to life through Orange and Hart Park. It continued through North Santa Ana where just west of Bristol Street the raging stream joined the similarly raging Santa Ana River.

Silverado Creek, which joins Santiago Creek at the mouth of Silverado Canyon, also raged and the hillsides became saturated. Loss of life occurred when part of the hillside behind the Silverado Fire Station gave way and crashed into the station where some residents had sought refuge. News accounts report that five people were killed and 17 injured in that one incident.

The junction of Santiago Creek and the Santa Ana River saw the water eroding the stream bed of Santiago Creek laterally, eating up the back yards of homes and threatening to undermine several homes to

the point they would be lost. County Flood Control crews worked to save those homes and called in the Marines from El Toro, who flew helicopters to that area. Wrecked cars hung from the copters on cables. The copters hovered over the raging water to lower the car bodies in place along the edge of the creek to help stop the erosion and save those homes. That strategy, coupled with a break in the weather, worked!

At the same time the Santa Ana River through Santa Ana Canyon was running full and fast. My colleagues in the County Flood Control Department feared that the river bank would give way where the river turns South as it exits the canyon in Anaheim, flooding Anaheim, just as it did in the late 1930s. A much denser population would have been at great risk in 1969. Fortunately, that did not happen again, but I have been told that it was a close call.

In March of that year I reported to work at my new job as Administrative Services Officer at the Harbor District on Bayside Drive in Newport Beach. This is the location where the Sheriff's Harbor Patrol Headquarters is today in Newport Harbor. Back then the Harbor Patrol was operated by the Harbor District, not the Sheriff's Department.

I quickly learned that a major tributary known as San Diego Creek that drained the area we know today as Irvine, Tustin, Lake Forest and parts of Newport Beach, ran into Upper Newport Bay on its journey to



the sea. In 1969 that meant the creek carried logs, brush and the refuse of the farming that covered thousands of acres. Keep in mind, Irvine and Lake Forest did not exist in 1969 but instead, contained various crops and a lot of wild, natural area, including vegetation.

When I arrived at Bayside Drive, I saw the Harbor Patrol boats towing in bundles of brush, logs, lumber and other material that had washed down San Diego Creek into Upper Newport Bay and then found its way to the boat slips, yachts and channels of Newport Harbor. Not only was this debris an unattractive nuisance, it presented a hazard to navigation, so the Harbor Patrol and maintenance personnel were bringing it to the Harbor Patrol docks, where it was loaded onto trucks and hauled to the nearby Coyote Canyon landfill. There was a lot of it and it was a dirty job that took weeks to clean up.

Now, here comes the surprise—the Harbor Patrol and maintenance personnel who wrestled that flotsam to the dock and on to the landfill found that some living things washed into the harbor with it, including rattlesnakes that were still alive! Need-


