The mission of REAOC is to promote and maintain fellowship and camaraderie of OCERS retirees and their spouses by sponsoring social and recreational activities and by maintaining contacts via the newsletter, the REAOC website, email, or other means of communication. A secondary purpose is tracking and dissemination of information relating to pension and legislative actions, financial matters, physical and mental health care, volunteer and employment opportunities and other concerns that may be of interest to our members.

OCERS retirees and their spouses are eligible for regular association membership. Dues are \$3.00 per month, payable through payroll deduction. Active employees, who will receive their retirement through OCERS, are eligible for Associate Membership. Dues for associate members are \$1.00 per month payable for the year each January.

Luncheons are held at Mile Square Golf Course in Fountain Valley on the fourth Wednesday of January, March, May and September, and on the first Wednesday of December. A local chapter of REAOC is active in Hemet.

SCAM Warning Signs

Published in the TCREA January Newsletter

You may receive telephone calls from time to time from unknown callers asking for personal information from you. You may be aware of some warning signs that indicate these are scams. The following are tips, some of which you may not be aware.

BEWARE OF THE FOLLOWING

- Pressure to give right now. A legitimate charity will welcome your donation whenever you choose to make it.
- A thank-you for a donation you don't recall making. Making you think you've already given to the cause is a common trick that unscrupulous fundraisers use to lower your resistance. Promises that 100 percent of a donation goes to whomever the charity claims to help. All charities have fundraising and administrative costs. Do check how watchdogs like Charity Navigator and CharityWatch rate an organization before you make a donation and con-

tact your state's charity regulator to verify that the organization is registered to raise money there.

- Do your own research online. The FTC recommends searching for a charity's name or a cause you want to support (like "animal welfare" or "homeless kids") with terms such as "highly rated charity," "complaints" and "scam."
- Do pay attention to the charity's name and web address. Scammers often mimic the names of familiar, trusted organizations to fool donors.
- Do ask how much of your donation goes to overhead and fundraising. One rule of thumb, used by the Better Business Bureau's BBB Wise Giving Alliance, is that at least 65 percent of a charity's total expenses should go directly to serving its mission.
- Do keep a record of your donations and regularly review your credit card account to make sure you weren't charged more than you

agreed to give or unknowingly signed up for a recurring donation.

- Don't give personal and financial information like your Social Security number, date of birth or bank account number to anyone soliciting a donation. Scammers use that data to steal money and identities.
- Don't make a donation with cash or by gift card or wire transfer. Credit cards and checks are safer.
- Don't click on links in unsolicited email, Facebook or Twitter fundraising messages; they can unleash malware.
- Don't donate by text without confirming the phone number on the charity's official website.
- Don't assume pleas for help on social media or crowdfunding sites such as GoFundMe are legitimate, especially in the wake of disasters. The FTC warns that fraudsters use real victims' stories and pictures to con people.

Fine Dining in "The '60s" San Francisco

As we have been purging drawers and shelves at home and tossing "stuff" that should have gone long ago, one discovery I thought worth sharing. My wife and I had been in our 20's in the late 1960s, no kids and two incomes from County jobs, and we took a trip to San Francisco to meet some friends who lived just north of the Bay area. We "splurged" and went out to dinner at a fancy, white tablecloth restaurant in Fisherman's Wharf called A Sabellas. According to a Google search this legendary restaurant closed in late 2007 after 87 years in business. When we ate there in about 1967, the staff let us


take a menu as a souvenir. I just found that menu in a drawer, and before I toss it, I thought I would share some items from it, so here goes:

- Bowl of Clam Chowder*.....\$**70**
- Lobster Thermidor*\$**4.75**
- Baked Sea Bass*\$**3.60**
- Chef's Special Platter – Crab legs, Scallops, Prawns, Oysters, Shrimps and Filet of Sole with tartar sauce, salad and vegetables*\$**3.75**
- Halibut Luciano – "A gourmet delight of Baked Halibut, smothered with creamed spinach and served with vegetables"*...\$**3.60**
- Prime Rib of Beef*.....\$**4.50**
- Filet Mignon*\$**5.75**
- Whole Cracked Crab*.....\$**3.50**

The desserts ranged from \$.60 to \$.75 with these choices: ice cream, sherbet, cheesecake, spumoni, pie, chocolate sundae, or Crème de Menthe sundae.

I could go on as it was an extensive menu. Suffice it so say, this was a top-flight restaurant at Fisherman's Wharf that, back

in the day, was very expensive! Things and prices have changed a bit in 50 plus years. Now back to the sorting and purging.



Do You Know Someone Who Needs A Ride?

Have you noticed anyone who previously attended our luncheons, but has not attended recently? If so, we encourage you to reach out to him or her. Perhaps he or she could use a ride. As you know, we always encourage members to carpool when convenient. If you personally cannot drive or locate a carpool partner and need a ride, have you thought about using a service like Lyft, Uber or other public transportation?

I contacted Lyft, Uber, Access, Amtrak and OCTA for cost estimates to Mile Square Park. REAOC recognizes these options may be cost prohibitive for many members. REAOC is not advertising or recommending these services. These are simply examples of available options.

According to Uber's cost-estimator website, <https://www.uber.com/fare-estimate>, as of February, a minimum charge of \$7.30 is standard. Rates range per mile and per minute. That might explain the cost difference between traveling ten miles from Santa Ana versus ten miles from Seal Beach. Of course, round trip would double these amounts, but you might find a ride home from the luncheon. According to Uber's estimates, one-way fees to Mile Square Park are approximately:

Uber
\$12 - 6 miles from South Coast Plaza
\$14 - 10 miles from the Santa Ana Train Station
\$23 - 10 miles from Leisure World, Seal Beach
\$18 - 15 miles from Buena Park Mall
\$37 - 18 miles from Laguna Woods

Lyft provided one-way, cost estimates from the following points of origin to our Mile Square Park facility. Again, round trip doubles the amount. Obviously, living farther from the luncheon can easily become more expensive without a vehicle. These are the most reasonable estimates provided from Lyft:

Lyft
\$15 from South Coast Plaza
\$14 from Santa Ana Civic Center
\$21 from Leisure World, Seal Beach
\$20 from Buena Park Mall
\$29 from Laguna Woods

Some retirees in Southern California live near the Amtrak train. I am aware of several who previously travelled to their County jobs via Amtrak. If you are one of these folks, try taking the train to Santa Ana and then use one of the above options to Mile Square Park. Discounts and information are available at <https://www.amtrak.com/seniors-discount>.

The bus may be an inexpensive alternative for some retirees. According to the OCTA website, <https://www.octa.net>, cash fare for local routes 60+ seniors and Medicare card holders is 75 cents. Express route rates range from \$3.50 to \$6.00 for seniors. Bus passes are also available at reduced rates.

I also contacted "Access," <https://accessla.org> for disabled persons. Information about the requirements to qualify for Access is available at the website. These rates

appeared to be significantly higher but do have discounts for seniors.

Our Hemet retirees may consider using some of their local public transportation and resources like Uber and Lyft for transportation as well.

The REAOC Board would love each of our members who would like to attend our luncheons to be able to do so. We discussed whether we could match riders similar to the County Rideshare Program, however, we are unable to do so. This is primarily due to the cost of liability. If transportation is or becomes an issue, we hope you will help each other and/or find an alternative way to join us.



New Medicare Mobile App

According to the US Dept. of Health and Human Services, a new free "app" is available for smartphone or tablet use anywhere you go. This app, What's Covered? may be downloaded from the App Store or Google Play.

You can use the app at the doctor's office, in the hospital, or anywhere you take your smartphone or tablet. Once it's installed, you can use it even when you are offline. You may search or browse to learn which medical items and services are covered, how to receive the covered benefits and basic cost information. If you are turning 70 soon, you may want to review the Required Minimum Distribution process reference your Deferred Compensation distribution. Beginning at age 70 1/2, participants with pre-tax savings accounts must begin taking distributions from your account in the form of regular payments. Failure to comply with IRS regulations related to this will result in a significant penalty. You may review these IRS regulations at <https://www.irs.gov/retirement-plans/retirement-plans-faqs-regarding-required-minimumdistributions>.
