We hope your summer months were spent relaxing and enjoying the company of family, friends and loved ones. Labor Day celebrations are almost here, as is entrance into the new Fall season. May the upcoming months bring cool weather, good times and perfect health to you and yours.

**Update** On July 16th the Board of Supervisors adopted 2020 retiree insurance plans and new rates. Rates vary by plan—some with double digit increases/decreases and others with moderate or minimal change. Although NOT included in the setting of rates or plan document negotiations, REAOOC representatives have and will continue to meet with Human Resources/Employee Benefits staff to better understand the rate setting process, specifically the County's self-funded Wellwise and Sharewell plans. [www.reaoc.org](http://www.reaoc.org). The County has provided an article on Page 2 of this newsletter to identify Open Enrollment dates, changes and timing of retiree Medical Plan Package mailings. As in the past, REAOOC will participate in Open Enrollment outreach efforts with Employee Benefits. A seminar especially for retirees has been scheduled for Tuesday, October 29th at the Mile Square Park Clubhouse in Fountain Valley. PLEASE SAVE THE DATE and join other REAOOC members to ask questions and determine the plan which best suits your needs. Your Board strongly recommends attending this seminar or one of the other seminars provided by the County.

### **Upcoming Activities**

On Tuesday, September 10th REAOOC Board members will participate in OCEA's Annual Health Fair to invite prospective retirees to join the REAOOC organization at retirement or, as an Associate Member, while they remain employed with the County. # 2020 Retiree Health Plan Open Enrollment

The Open Enrollment for the 2020 health plan year will be from October 25th through November 15th 2019. Your Open Enrollment package should arrive at your home mailing address just before Open Enrollment and will contain the 2020 health plans rates and options. If you have moved, please report your new address to the Benefits Center at 1-800-858-7266.

• The Open Enrollment meeting on Tuesday 10/29/19 at Miles Square Park will be hosted by REAOC and attended by Employee Benefits staff and the Retiree Health Plan representatives for Non-Medicare and Medicare Retirees.

• Based on attendance this will be the only live Open Enrollment presentations for Non-Medicare retirees and we will be introducing recorded webinars.

• The schedule for remaining Medicare retiree live presentations will be in your Open Enrollment package.

Some important things to be aware of while you await your Open Enrollment package:

**Changes to the Sharewell Retiree Health Plan** Beginning January 1, 2020, OptumRx will be the prescription claims administrator for the Sharewell Retiree Health Plan.

Effective 1/1/20, this change will result in utilization management programs being added and a change in the list of covered medications (formulary). These changes are designed to provide members with clinically appropriate medication(s) while saving you and the plan money.

**2020 Premium Rates for County Retiree Health Plans** Some plans will be experiencing significant increases for 2020. The retiree health plan increases will be addressed in the upcoming Retiree Newsletter that will be delivered to your home address mid-October.

For more information about these changes you can attend an Open Enrollment Presentation. Additional communications with important details about these changes will be mailed later this year. Be sure to open and carefully read all the information mailed to you by Employee Benefits and OptumRx in the weeks and months ahead so you have all the information you need on resources and deadlines, especially if you want to consider changing plans.

The Benefits Center call center representatives will be ready to answer your detailed questions once Open Enrollment begins on October 25th. Please hold your questions until that date so staff can be trained and provided all the details needed.

## Audit Results

**Y**our REAOC Board of Directors is pleased to report that for the year ended December 31, 2018, the accountancy corporation of Daniel J. Leonard III, CPA has audited REAOC's books and that for the eighth year in a row, has opined that the financial statements present fairly, in all material respects, the financial position of REAOC and the results of its operations and its cash flows. REAOC chooses to prepare the

financial statements on the cash basis of accounting and not the accrual basis, therefore, the opinion is clean except for the fact that the cash basis of accounting is used which is a comprehensive basis of accounting other than generally accepted accounting principles. Additionally, no reportable significant internal control deficiencies were noted during the audit.

# CRCEA Spring Conference Recap

This year's CRCEA Spring Conference was hosted by San Diego County's Retiree Association, RESDC, from April 15 – 18, 2019. REAOC attendees included our Co- Presidents, Linda Robinson and Doug Storm, Director Gaylan Harris, AREOC Secretary Lou Scarpino and Executive Director, Ilene Barcenas.

We were welcomed to the conference by Dianne Jacob, Chair San Diego County Supervisor. She stated that a large factor in the health of the county and its pension is the size of the senior population. They know that this is going to lead to more with Alzheimer's Disease (AD)—the 3rd leading cause of death in San Diego County.

Continuing with that theme, the Keynote Address was "Alzheimer's Disease Therapeutics: State of the Field" presented by Dr. Paul Alsen, Professor Neurology, Director USC Alzheimer's Therapeutic Research Institute (ATRI).

The USC Alzheimer's Therapeutic Research Institute in San Diego opened twenty years ago with the mission to improve the treatment effectiveness in the progression of Alzheimer's disease. This research has occurred for over 30 years (formerly through UCSD) and has developed new techniques, candidate therapies, clinical trials, etc. Current statistics:

- 50 million seniors have had AD dementia worldwide; 10 million new cases per year
- As populations age, the number of cases of AD dementia will grow to 130 million in 2050

- Annual economic impact is greater than \$1 trillion

With Alzheimer's there are two abnormalities in the brain—neurofibrillary tangles—rope-like changes in brain cells and amyloid plaques—speckled deposits in the nerve cells. The brain loses tissue and becomes smaller. Atrophy of the brain is caused by Alzheimer's at the memory portion of the brain.

The disease was first identified in 1906 by Dr. Alois Alzheimer. Originally, he thought Alzheimer's Disease began with dementia, but scientists could not make the definitive diagnosis until after death when they could view the brain. They learned that Alzheimer's Disease is always fatal. From that time until the 1970s the general assumption was that this is an unusual and untreatable degenerative disease of middle age. In mid to the late 1970's, there was a hypothesis that suggested treatment possibilities.

The beginning of AD therapeutics at that time included the National Institute on Aging (NIA) which supported the development of AD trial methods. All of the drugs that are now being used are based on the studies that were done by the NIA.

## Finding new treatments for AD

How were decisions made as to which new treatments were tested in randomized controlled trials?

- Basic research studies
- Epidemiology

Negative trials (mainly based on epidemiology) were found to be unsuccessful. Moving away from epidemiology the experts in the field moved on to genetics and neurobiol-

ogy. They have done many trials to get rid of the peptides but none of them worked. The industry performed more drug trials that were promising but had no positive effect on the patients.

## How can we do better?

New tools are available including the optimization of drugs and drug doses, earlier treatment, and utilizing Amyloid PET scans to view the amyloid accumulation in the brain as well as the tangles. Amyloid plaques precede dementia by at least 15 years.

## How can we prevent or slow the disease?

We must identify those who have the signs before the disease appears. There must be an intervention while the brain is functioning normally. Dr. Alsen and his colleagues estimate that it will be 4-8 years before we have a drug that will cure AD.

# The Day John Wayne Called My Mother

Retiree John Garrity submitted his recollection of a very special event in his life involving his mother and John Wayne.

In September, 1976 my mother was in the hospital for a mastectomy. Her long bout with cancer had methodically progressed so that surgery was the only answer. I cannot recall a time when I saw my mother so tired, afraid and depressed. It is at these times when you hope but realize there is not enough candy or flowers in the world to take your mind off the fact that you are about to lose part of your body and maybe your life. If only I could do something for her.

My mom had always been a big movie fan and John Wayne was one of her all-time favorites. I had been a peace officer in the Southern California area for many years and I just happened to know where Wayne lived. The thought of telling him about my mother's plight seemed crazy and impossible. Who was I to burden one of the biggest movie stars ever with my personal problems? Nevertheless, thoughts of my mother's condition compelled me to try. Besides, what did I have to lose? All he could say was "No."

The day before her surgery, I found myself at Wayne's doorstep. As I knocked on the door, thoughts of running away entered my mind. His secretary answered the door. I identified myself with my badge and asked if I could speak to Wayne about a personal matter. She quickly responded that Wayne was quite busy at the moment opening his mail. With a look of dejection on my



face, I apologized for the inconvenience and started to leave. About halfway down the walkway I heard her say, "Oh hell, he's not that busy. Come on in." She showed me into a large room where Wayne was sitting. As he stood up and looked toward me, my heart seemed to stop as I stared directly into the face of my hero for the past 36 years. He was bigger than life.

Following a few moments of uncomfortable silence, I identified myself once again and briefly explained to him the physical and emotional condition of my mother. It was only a few years before that John Wayne had apparently won his own personal battle with cancer.

I asked if he could take the time to give her a call before she went into surgery. His gracious response brought tears to my eyes as he assured me that he would call her and try to lift her spirits. He personally walked me out of the house and we said goodbye. As I drove away, I was trying to comprehend what had just taken place. Would John Wayne really call my mother?

I went straight to the hospital to visit my mother. I knew I could not say one word about Wayne. As I walked down the hospital corridor, there seemed to be a great deal of commotion among the nurses and orderlies near the entrance of my mother's room. Considering her medical status, I immediately sensed a serious problem.

When I got to the door of her room, there was mom sitting up in her bed holding court for anyone who would listen, reciting every word John Wayne had said on the phone. When she saw me, she wanted to know why I hadn't told her that John Wayne was going to call.

I have never seen my mom so excited and for a few brief moments, she forgot about all of her fears and pain.

A few weeks later, I saw Wayne in front of his house. I stopped by and thanked him for the kindness he showed to my mother. She died just three years later, but she never tired of telling her John Wayne story. Thanks again, John Wayne, wherever you are, you are still my hero.
