REAOC representatives attend Orange County Employees Retirement System (OCERS) regular and additional monthly meetings. Weekly and/or bi-weekly current news articles of interest to retirees are updated regularly on the REAOC website at www.reaoc.org. There is much to be done and your Board is committed to doing our best to provide our members with the service you expect and deserve.

2021 HEALTH PLANS

The Board of Supervisors adopted 2021 retiree insurance plans and new rates at their Board meeting held July 14. Rate increases and decreases vary by plan—some with double digit increases/decreases and others with moderate, minimal or no change. REAOC is NOT included in the negotiation or setting of rates; however, representatives from REAOC continue to meet with Human Resources/Employee Benefits staff to gain a better understanding of plan Rx and medical service experience and the rate setting process. The new 2021 rates are posted on the REAOC website at www.reaoc.org. Rate or plan design changes will depend upon plan enrollment.

For a number of years REAOC has co-hosted an annual workshop in Fountain Valley regarding health plan design changes and new rates.

Representatives from each of the offered plans provide presentations and answer questions posed by retirees. Due to the considerable health risks raised by large group gatherings, REAOC and the County are exploring the best way to communicate health plan offerings to our membership. Open enrollment will begin October 23rd and end November 13th, 2020. REAOC will update our members and plan participants as soon as additional data is available to assist in the upcoming open enrollment process.

REAOC provides pertinent information (including open enrollment activities) to our members via newsletter, email and on the REAOC website. If you have changed your email address or have not provided REAOC with your email address, please consider doing so now. Communication is very important in today's world and we want to reach as many members as possible when sending out alerts, notices and updated information.

5 Reasons to Wear a Face Mask

The plea from health experts for the public to wear face masks has intensified in recent weeks, as coronavirus cases continue to climb in many areas of the U.S. And a lot of it has to do with what researchers are learning about the effectiveness of face coverings.

A growing number of studies point to the mask as a powerful tool that can help control the spread of the coronavirus, which so far has infected more than 2.6 million Americans. Here are five reasons to wear a mask, based on the latest research.

1. MASKS PROTECT OTHER PEOPLE

The primary way the coronavirus spreads is from person to person by respiratory droplets produced when an infected person coughs, sneezes or talks. Face masks, however, can block these droplets. They act as a barrier to keep virus-containing particles from escaping an infected individual and landing on another person.

"There's no question; it's indisputable that wearing even a cloth face covering cuts down substantially on the amount of virus that's shared by an individual," said Ron Waldman, MD, professor of global health at the George Washington University Milken Institute School of Public Health.

2. YOU MAY NOT REALIZE YOU ARE CONTAGIOUS

It used to be that masks were recommended only for people who knew they had COVID-19, as a way to protect others around them. When it became apparent, however, that the virus can be transmitted by people before they start showing symptoms (pre-symptomatic) and by people



who never develop symptoms (asymptomatic), the Centers for Disease Control and Prevention (CDC) broadened its guidelines, urging everyone to wear a cloth face covering in public.

Some studies, including a paper recently published in the journal *Nature*, have found that over 40 percent of people with coronavirus infections never develop symptoms of COVID-19. That is why wearing a mask is important, even if you believe you are healthy.

"It's a sense of social responsibility," says Neysa Ernst, R.N., a nurse manager of the Biocontainment Unit at the Johns Hopkins Hospital in Baltimore.

3. MASKS CAN PROTECT YOU, AS WELL

A few studies suggest cloth face masks offer some protection for the wearer, but the protective perks are most obvious when everyone covers the mouth and nose. Think of it as a collective benefit: The more people who block the transmission of the virus with face coverings, the less virus there is circulating in the community. This reduces everyone's risk for infection.

"Beyond a doubt, [face masks] play an important role in reducing transmission," Waldman says.

4. MASKS MAY HELP THE ECONOMY RECOVER

Masks could offer an economic boon, as well. Recent spikes in coronavirus cases have caused some U.S. communities to pause or roll back reopening plans and "have raised fears that we may need to go back to the lockdowns that we saw back in March and April," Jan Hatzius, head of Goldman Sachs Research and the firm's chief economist, explained in a video briefing on the report.

"We know that's very economically damaging." And slowing the rate of new cases would "reduce the need for what otherwise would be a significant hit to the economy," Hatzius said.



5. THERE ARE FEW ALTERNATIVES

In the absence of a vaccine and more effective drug therapies to treat people who are sick with COVID-19, the preventive measures of hand-washing, physical distancing and mask wearing are "the three things that I do know that work" when it comes to fighting the coronavirus, Johns Hopkins' Ernst says.

County of Orange Health Plan Open Enrollment for 2021

Mark your calendars! October 23 through November 13, 2020 will be Open Enrollment for 2021. If you have moved, notify the new Benefits Service Center at 1-833-476-2347. This will ensure you receive all the important information regarding Open Enrollment.

Open Enrollment allows you the opportunity to add or remove a dependent from your retiree health coverage and/or make a new retiree

health plan election. Elections made during Open Enrollment are effective January 1, 2021.

New for Open Enrollment 2021, you will have access to the My OC Benefits™ website Pre-Open Enrollment page to go out before the start of Open Enrollment and find out what is new, 2021 rates, and view your health plan options. Visit My OC Benefits™ at mybenefits.ocgov.com. If this is the first time you are logging in, look for “New User?” under

the Log On button. Access the website through Chrome, Edge or Firefox. If you need assistance with navigating the My OC Benefits™ website, refer to the Quick Reference Guide mailed to your home in late June.

Contact the Benefits Service Center at 1-833-476-2347 between 8 a.m. and 6 p.m. Pacific Time, Monday through Friday. Representatives are available to answer your questions and/or will take your Open Enrollment elections.

Slate of Directors and Officers and REAOC Bylaws

Due to the current COVID-19 situation we are unable to follow the current guidelines found in our current REAOC bylaws. Each year at our September REAOC luncheon, we announce the slate of Directors and Officers for the upcoming year and ask for any nominations for those positions. Every year at our December luncheon, REAOC holds the Annual Meeting and a major topic of business at this meeting is the election of Directors and Officers. Due to the current pandemic situation, we are unable to have the in-person meetings this year. We will continue with the current slate of Directors and Officers until we can hold the face-to-face meetings for our 2021 process.

Knowing that we must adjust the process of nominating and electing Directors and Officers, it is necessary that we revise the article below found in our REAOC bylaws. Below please find the recommended bylaw changes to address the current situation and any similar issue that may arise. As soon as we are able to meet once again, we will vote on the rec-

ommended bylaws below.

Article III

Annual Meeting – Election of Directors and Officers – Tenure

SECTION 1. ANNUAL MEETING

There shall be an annual meeting. At this meeting, the Directors and Officers of the Association shall be elected and installed. All Directors and Officers will serve for the next calendar year. *If there is any cause for cancellation of the annual meeting, the current Directors and Officers will remain in their positions until an annual meeting can be rescheduled. At that rescheduled meeting and in the presence of the nominated Directors and Officers and at least 100 REAOC members in good standing (exclusive of the elected officers), the Directors and Officers of the Association shall be elected and installed. If there is a*

need in the future, voting electronically or by mail may also be considered as an option to elect the REAOC Directors and Officers.

SECTION 2. ELECTION OF DIRECTORS AND OFFICERS

The Nominating Committee shall nominate candidates for each office. The names of the nominees will be presented at the Association's regular General Meeting immediately prior to the Annual Meeting and included in an *Informer* article. *If there is any cause for cancellation of the General Meeting and the Annual meeting, the nomination for candidates for each office will be held when it is possible to have a face-to-face meeting of the REAOC Board and at least 100 REAOC members in good standing (exclusive of the elected officers).*

Election of Directors and Officers shall be by a vote at the Annual Meeting (*please refer to Section I for any exceptions*). A majority vote of members present and voting shall be necessary to elect. When there is only one nominee for an office, he or she may be elected by acclamation.
