# Presidents' Message

Fall will be a welcomed change from the stifling heat we've recently experienced. And speaking of heat, the political season is, once again, gaining momentum and it may be difficult to ignore media headlines and subjective commentaries. As we've said in the past, PLEASE stay as cool and calm as you can. Let's sort out fact from fiction as we all deal with challenging and uncertain times. As retirees we've been through situations like these before and have the experience, strength and ability to address any challenges we faceconfidently and with wisdom.

#### RETIREE MEDICAL INSURANCE UPDATE

On July 18 the Board of Supervisors adopted 2024 retiree insurance plans and new rates. It will be very important for all enrollees to carefully review current plan changes and costs for 2024. Rate increases/decreases vary by plan and whether you are post-65 and Medicare-eligible or pre-65. REAOC is NOT included in plan negotiations or rate setting; however, dedicated representatives from REAOC continue to meet with Human Resources/Employee Benefits staff to gain a better understanding

of plan Rx and medical service experience as well as the rate setting process. The new 2024 rates are posted on the REAOC website at www.reaoc.org. Please refer to Pages 3 and 5 of this newsletter for information pertaining to significant plan changes which will occur for both pre- and post-65 retirees currently enrolled in Anthem Blue Cross plans: plans which will NO LONGER be available in 2024. Further, effective January 2024, pre-65 retirees will be combined with current employees in a blended, co-mingled insurance pool. This action will likely reduce insurance coverage for pre-65 retirees.

REAOC is co-hosting an Open Enrollment workshop on October 16, 2023. The workshop will provide presentations by insurance providers and County staff detailing health plan offerings, design changes and 2024 rates. The workshop will be held at the County Administration South (CAS) conference center located at 601 North Ross Street in Santa Ana. Post-65 presentations will be held from 9:00 AM to 11:00 AM and pre-65 presentations from 1:00 PM to

# **REAOC Benefit Plans Open Enrollment**

the upcoming 2024 Open Enrollment period for REAOC benefit plans. Plans include two high benefit dental plans (PPO & HMO), a VSP vision plan, legal services, identity theft protection, pet care, travel protection, life insurance, accident coverage, and much more. This is your once-a-year chance to enroll in or make changes to your dental and vision coverages.

All retirees will receive their annual Open Enrollment Benefits Guide in the mail, and you should have it no later than October 15th.

This guide details the benefit plans offered exclusively to REAOC members. The Benefit Guides are mailed to the address OCERS (not REAOC) has on file, so if you have moved, please make sure they have your current address.

If you are NOT making changes to your coverages, you do NOT need to return the Enrollment Form. Your enrolled coverages will continue for 2024. If you do plan on making changes or enrolling for the first time, we will need your enrollment form back no later than November 10th.

# 2023 Keith Concannon Scholarship Award Winners

This is the 19th year scholarships have been awarded to qualified students who are related to REAOC members, and are pursuing a degree at an accredited college, university, or authorized institution. Our committee consisted of two volunteers from the Orange County Department of Education, Ryan Crowdis and Brenda Carvajal-Muniz. We thank them for their invaluable insights and willingness to help. Frank Eley served as the Chair of the Scholarship Committee and was joined by REAOC member and past Scholarship Chair Rebecca Guider.

Scholarships of \$2,000 were awarded on the basis of academic performance and achievements, community service and honors. The process requires that all identifying information be removed before the Committee Members receive them for review. The Scholarship Committee members do not know the names of any of the recipients until after the selection process is fully completed. The REAOC Board

Benjamin Zietz is the son of David Zietz who retired from the county in 2002, Benjamin is a junior at UCLA and hopes to graduate and go on to optometry school. Not just an academic, Benjamin is also a world class baton twirler who finished 6th in the 2002 World Championships held in Eindhoven, NL. He was the first male Feature Baton Twirler in UCLA history. # How to Stop Stalling On Getting a Will and Estate Plan

Simple, essential steps for putting your affairs in order by Sarah Mahoney and Sheila Anne Feeney, AARP, Updated June 30, 2023

he steady drone of coronavirus news has spurred countless older Americans to face a long-procrastinated task: writing—or rewriting—their wills. But millions of Americans have yet to do so. A 2016 Gallup poll found that more than 30 percent of people 65 and older didn't have a will, nor did more than 40 percent of people ages 50 through 64. The main reasons people stall, according to *Caring.com?* They say either that they just haven't gotten around to it or they don't have enough assets to leave to anyone.

Neither is a great reason. Thanks to DIY software, it's possible to pull together a smart, effective will in less than an hour. And assets are only part of the story. Even if you have no savings to pass on, the right paperwork can save your loved ones headaches and heartache. Some essential things to know about end-of-life planning:

You need more than a will. A will directs what happens after a person dies and makes life simpler for heirs. often saving families thousands in unnecessary probate fees. But two other documents are just as important. One is a health care directive, sometimes called a living will, which appoints someone of your choice to make medical decisions for you if you're unable, and which outlines the medical care you do or don't want. The other document is a durable power of attorney, which appoints someone to make financial decisions on your behalf if you're incapacitated.

These documents require hard conversations. Try to have them any-

way. Another reason people delay is "they worry talking about death will upset their spouse and family," says Al Cutturini, director of the Elder Law Project for North Mississippi Rural Legal Services. "But that's not true. While it can be uncomfortable, knowing a parent's wishes about everything from medical care to funeral plans is very reassuring," he says. "It gives families an enormous sense of relief when they know what to expect."

Every state is different. Laws can vary a lot. In some states, for example, spouses inherit everything if you die without a will. In others, they get only a child's share. A few recognize oral wills if witnessed properly, while others don't. "That's why it's important to work with a lawyer licensed in your state," Cutturini says. "Even if you're planning to move, I always tell clients to get a will right now, and then update it."

You can write one any time, even if you're sick. Hospitals aren't the ideal place to make a will, but it's better than not doing it at all. "It's valid the minute it is signed," Cutturini says.

Don't cling to tradition. Many people still feel that they should name the oldest child—maybe even the oldest male child—as executor of the will and the agent to oversee their health care and money. It's often a recipe for disaster, says Gary Bauer, professor emeritus at Cooley Law School at Western Michigan University. "Select your agents based upon their ability to manage your affairs, not birth order," he says. Who's the most organized and

responsible? Who lives closest? Is there a natural leader, most likely to handle any conflict that arises later? And don't be afraid to split duties. "Someone making end-of-life decisions has a very different role than someone distributing property after someone has passed," he says.

Joint wills are a terrible idea. Experts caution couples against joint wills, and they aren't even valid in some states. Such wills can restrict a surviving spouse from changing it later, even if his or her circumstances alter radically. Instead, many couples opt for "mirror" wills. These virtually identical documents allow each spouse to leave the estate to the other, and then to their children.

Either treat all children the same or prepare for blowback.

Leaving more to one child or leaving one out entirely, "almost guarantees dissent and challenges later," Bauer says. "Feelings are hurt and balloon into legal hearings after death.

Getting a smaller share than your siblings feels like a slap in the face in perpetuity." If you do create an imbalance, talk that decision out with your children now, to avoid legal action later. And know that stepchildren aren't automatically treated as children for legal purposes. For them to share in an inheritance, they must be specifically named.

It's not one and done.

Sometimes, these three documents can be done just once. But if there's a major life event, such as a move to a new state, or a beneficiary or agent becomes ill, is disabled or dies, they'll need to be revised.
