Fall 2023 California Retiree County Employee Association (CRCEA) Conference

he Fall 2023 CRCEA
Conference held October 1-4,
2023, was hosted by San
Joaquin County's retiree association,
Retired Public Employees of San
Joaquin County (RPESJC). REAOC
was represented by our CoPresidents, Linda Robinson and
Doug Storm, and Executive Director,
Ilene Barcenas.

We were welcomed to the conference by RPESJC President, Bill Mitchell. He aacknowledged the conference committee chair, Joe Chelli, and members of his committee group and Board members.

There were several interesting agenda topics included: The future with Artificial Intelligence (AI), Senior Fraud and Prevention, San Joaquin County's Master Plan on Aging, Promoting Physical Activity through the Community, the legislation update and a speaker who shared information about the topic of homelessness.

The speaker for the topic of homelessness was Adam Cheshire, the Homeless Coordinator of San Joaquin County. Many of the counties in attendance could relate to this topic as they are also seeing a rise in the senior homeless population. The highlights from the presentation include:

Nationwide, senior homelessness is on the rise according to HUD data, particularly in shelters.

 $\sqrt{\mbox{Typically}},$ we define "senior" in this context as those over age 50 and use the term "older adults."

√ There were 18% more older adults experiencing homelessness in 2021 than in 2020, the latest data officially released by HUD.

 California's proportion of older adults experiencing homelessness is increasing, according to a major statewide study recently completed by the Benioff Institute at UCSF.

 $\sqrt{\text{Among single homeless adults}}$, 48% were 50 and older.

√ Among single adults 50 and older, 41% became homeless for the first time at age 50 or older.

 According to data collected in 2022 by the San Joaquin Continuum of Care:

 $\sqrt{5.8\%}$ of those in Emergency Shelters were seniors.

 $\sqrt{12.7\%}$ of those contacted by Street Outreach were seniors.

 $\sqrt{7.8\%}$ of those in Permanent Housing projects were seniors.

 $\sqrt{34.6\%}$ of those in Permanent Supportive Housing for the chronically homeless were seniors.

In the first 9 months of 2023:

 $\sqrt{7.7\%}$ of those in Emergency Shelters were seniors: 454 were over age 62, with 415 between the ages of 55-61.

 $\sqrt{13.1\%}$ of those contacted by Street Outreach were seniors.

 $\sqrt{7.5\%}$ of those in all kinds of Permanent Housing projects were seniors.

 $\sqrt{36.6\%}$ of those in Permanent Supportive Housing for the chronically homeless were seniors.

- In San Joaquin County, seniors make up a larger percentage of the unsheltered population than the sheltered population. This is partly because many of the community's Emergency Shelters are focused on families with minor children, and those households skew younger.
- As defined by HUD, "chronic homelessness" means that an individual has been homeless for a prolonged period and has a permanent disabling condition.

 Seniors make up a significant percentage of those who are chronically homeless, making them more vulnerable to long-term homelessness.

√ It should also be noted that when someone is disabled and becomes homeless, they are far more likely to remain homeless than an individual who does not have a disabling condition, regardless of age.

CALPERS Long Term Care Insurance Settlement Finalized!

he settlement became final on September 28, 2023. No appeals were filed against the settlement.

Category A Class Members who elected Option 1 – Premium Refund:

The information in this paragraph only applies to Class Members who elected to surrender their Policies and receive an 80% premium refund (less any benefits received).

The Final Settlement Date was September 28, 2023, which means your CalPERS LTC Policy will be surrendered and you can stop paying premiums as of that date. You will be notified in January 2024 of your final refund amount, but please understand that it will include 80% of all premiums paid to CalPERS (less any benefits received) through the Final Settlement Date. We have been advised by CalPERS that premium payments deducted from Class Members' pension checks or that are set up for autopay through their bank accounts should stop automatically, and any payments deducted after

September 27 will be refunded by CalPERS. If you make the payment to CalPERS by check, you should stop sending premium payments.

Class Members who elected Option 1 but recently went On-Claim, applied to go On-Claim, or think they may need to go On-Claim:

, If you elected Option 1, but applied to go On-Claim or went On-Claim before September 28, 2023, or believe you may need to go On-Claim before October 28, 2023, then you may qualify for Category I or another process provided for in the Settlement that would allow you to reverse your election. Per the REAOC Bylaws, the following must take place:

ARTICLE III ANNUAL MEETING – ELECTION OF DIRECTORS AND OFFICERS – TENURE

Section 1. ANNUAL MEETING

There shall be an annual meeting. At this meeting the Directors and Officers of the Association shall be elected and installed. All Directors and Officers will serve for the next calendar year.

Section 2. ELECTION OF DIRECTORS AND OFFICERS

The Nominating Committee shall nominate candidates for each office.

The names of the nominees will be presented at the Association's regular General Meeting immediately prior to the Annual Meeting and included in an *Informer* article. Election of Directors and Officers shall be by a vote at the Annual Meeting. A majority vote of members present and voting shall be necessary to elect. When there is only one nominee for an office, he or she may be elected by acclamation.

During the annual meeting at the REAOC luncheon on December 6, 2023, the Directors and Officers for REAOC shall be elected by the REAOC members in attendance and installed.

Remember, REAOC is only as strong as the commitment of its individual members! We very much appreciate the new volunteer Officers and Directors who will, if elected, assist the REAOC Board and will serve all the retirees.

Operation Santa Claus and Senior Santa & Friends

gifts and toys to
children who are

abandoned, neglected, and/or abused and are placed in foster care in Orange County. In addition, Operation Santa Claus provides new holiday gifts to children of disadvantaged families who are receiving services from the County of Orange.

Operation Santa Claus is a County of Orange Board of Supervisors approved program and is the only official County holiday toy drive. Last year this program distributed over 16,000 new toys and gifts, bringing joy and a message of hope to our most vulnerable children in Orange County who might otherwise have gone without. This would not be possible without the generosity and collaborative effort of County of Orange employees, churches, businesses and individuals in the community who play an important role in collecting toys.

The Operation Santa Claus program is coordinated by the Orange County Social Services Agency, with support from community volunteers.

Approximately 1,800 hours annually are graciously given by volunteers from County agencies and the community. These holiday and year-round volunteers have been the backbone of Operation Santa Claus since its inception.

The Operation Santa Claus program has greatly expanded over the past several decades. What began as a small effort to meet the needs of a handful of children in 1962 has become a major event for the community. gifts and special request items to low-income individuals who are elderly or adults who are severely disabled.

The individuals are clients of Orange County Social Services Agency and/or the Orange County Health Care Agency. Each year staff identifies clients who would benefit from having such things as household

appliances, special medical equipment, nutritional supplements, or clothing. Often times these individuals are isolated from family and their community. Items received through Senior Santa & Friends help to enhance the quality of life, making life easier, more comfortable or more independent. Last year Senior Santa & Friends provided almost 2,800 gifts to this vulnerable population. This was largely due to the efforts of volunteers and donations received from County employees, private companies, community-based organizations and private individuals who donate to Senior Santa & Friends annually.

Opportunity to Serve as a Grand Juror!

very year the Superior Court of Orange County is required by law to empanel a 19-member Grand Jury to serve a one-year term. The Court is seeking qualified and capable individuals, like you, to serve the Orange County community in this unique role for the term that begins July 1, 2024.

This is a wonderful opportunity for OC retirees and REAOC members

to get a behind-the-scenes look at the workings of local government agencies and recommend areas for improvement. The Grand Jury also decides on indictments for some criminal cases.

lists the qualifications and an overview of duties; it also includes a timeline on the second page with important dates. The current stipend for serving is \$50/day, plus mileage and a reserved parking space, as set by the O.C. Board of Supervisors. The Grand Jury meets at the Central Justice Center in Santa Ana.

Three Great Ideas to Minimize Potential Damage if Your Wallet Is Stolen

ou reach for your wallet to settle up a bill and find nothing. Panic sets in as you frantically pat down your pockets or fumble around the contents of your purse. It's gone. Losing whatever cash you may have on hand is bad enough, but the other contents in your wallet can be a treasure trove for criminals, who can go on to perpetrate credit card fraud and identity theft.

The silver lining: Act fast and you can minimize much of the potential damage. Here's where to start.

1. Cancel your debit and credit cards

Credit or debit accounts should be closed as soon as possible. Call the bank or credit card companies that issued the cards that were in vour wallet and cancel them. Request replacements with new account numbers. Deal with your debit card first. "The debit card is the gateway into your bank account," says Adam Levin, founder of CyberScout, author of Swiped: How to Protect Yourself in a World Full of Scammers. Phishers. and Identity Thieves, and cohost of the weekly podcast What the Hack With Adam Levin. "If someone steals vour credit card and uses it. they're spending the credit card company's money," he notes.

Adding to the urgency: With a credit card, you have 60 days to report your loss, and the most you will owe for unauthorized charges on the card is \$50. The terms are less friendly when it comes to debit cards. By federal law, you have two business days to refute unauthorized charges on a debit card. If you report within two business days of learning about the theft, the most you may be liable for is \$50. If you report it after more than two business days, your

maximum loss is \$500. Report it after 60 calendar days, and you could be liable for the entire amount stolen.

The faster you can cancel that card, if it goes missing, the better.

2. Freeze your credit

With your driver's license in hand, a thief has enough information to do some serious damage. Putting a freeze in place blocks lenders and creditors from accessing your credit report, so someone else won't be able to take out credit in your name.

"If lenders can't see your scores, they don't know what their risk quotient is, so they're not going to issue that new card or approve that loan," says cybersecurity expert and private investigator Robert Siciliano. Contact each of the three national credit reporting bureaus—Experian, TransUnion and Equifax—and ask them not to share your credit report or information with anyone. There is no cost for this. (Read our story for more on how to, and why you'd want to, freeze your credit).

Or ask the credit bureaus to place a fraud alert on your credit. A fraud alert notifies creditors, lenders or anyone viewing your credit report that someone may be trying to apply for credit fraudulently in your name. Read the free credit report that each bureau will send you after your request to check for unfamiliar activity or suspicious new lines of credit.

3. File a police report

Call your local precinct to get a police report on record. Even though the police may not be able to recover your missing wallet, it's a crucial piece of documentation to have on hand.

With a police report, you have evidence of theft in case someone tries to use your info for fraud. "This

is for your own protection," says
Chelsea Binns, former president of
the New York Chapter of the
Association of Certified Fraud
Examiners and assistant professor at
John Jay College of Criminal Justice
in New York City. Also, she says, if
someone finds your wallet, a filed
police report will have your contact
info so the items can be returned to
you quickly.

Grand Jury is a full-time position for a full year. Orange County, with a population of more than three million people, numerous facilities, agencies, and challenges, has become so complex that members of the Grand Jury must be prepared to devote time and energy to the needs and demands of this activity. The Grand Jury normally works a five-day week. Jurors must be flexible and able to serve some evening and weekend hours in addition to normal business hours. Generally, we discourage jurors from planning vacations during the course of their term as a Grand Juror. If a vacation is needed. Jurors are requested to make it brief (one to two weeks). Although it is recognized that illnesses and other emergencies may prevent attendance at all sessions, members are expected to make a special effort to be present to fulfill their responsibilities as much as possible. Prospective grand jurors
