I. The AREOC Board meeting was called to order at 11:07 AM by the President, Sara Ruckle Harms

II. Approval of Minutes January 9, 2013

Sara Ruckle Harms led a discussion regarding the proposed budget for 2013. The budget for 2013 is exactly the same as the 2012 AREOC budget. If need be, there could be a mid-year adjustment for the 2013 budget. The membership numbers will be reconciled with the 2013 REAOC budgeted numbers and will be changed to 4,953 members.

Motion made by Linda Robinson and seconded by Doug Storm to approve the 2013 AREOC Budget as amended per the discussion. Motion carried.

Motion made by John LaRoche and seconded by Larry Leaman to authorize payment as budgeted to a maximum of \$2,500 to the accountant, Daniel Leonard, for the review/audit and tax preparation of the 2012 taxes. Motion carried.
