Regular Board Meeting Wednesday, November 14, 2012

I. The AREOC meeting was called to order at 12:20 PM by the President, Sara Ruckle Harms

Lou Scarpino also discussed having opportunities to present this paper in front of groups – especially those who may be against public pensions. Sara Ruckle Harms stated that it may be appropriate to share with the OCERS Board at some point. Chuck Hulse stated that it might be useful to present this to smaller groups such as the Lions Club who are not as aware of this subject. The OC Business Council (Lucy Dunn is the Director) could be an audience group for presentation of this material.
