# I. The AREOC Board meeting was called to order at 11:38 AM by the President, Sara Ruckle Harms

Sara Ruckle Harms discussed a draft of the AREOC budget for 2014. As the cost of legal fees are unknown, it may be best to use the actual expenditures as assumptions of our need for 2014. Gaylan Harris stated that we also need to consider a benefit consultant that would be budgeted in the AREOC budget. It would be interesting to know what the true impact of the Affordable Care Act is for County Medicare retirees.
